

Darling Quarter Retail: Run the Harbour - Women's Health Week

Terms and Conditions

These terms and conditions are for all entrants who enter the 'Run the Harbour' Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

The Promoter is LLFML atf Darling Walk Trust, Building Management Office, 1 Harbour Street, Sydney NSW 2000 (ABN 24 634 378 816), Trading as Darling Quarter.

ELIGIBILITY

This Promotion is only open to NSW residents who are 18 years old or older.

The following persons are ineligible for the Promotion: (i) directors and employees of the Promoter, its related companies or any of its agencies; retailers and staff that are associated with the Promotion (ii) the spouse, defacto spouse, parent, child or sibling of an aforementioned excluded person; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

The Promotion commences at 7:00am Australian Eastern Standard Time ("AEST") on Wednesday, 9 September 2026 and closes at the conclusion of the event on the same day ("AEST"). ("Promotion Period")

HOW TO ENTER

To enter this Promotion, eligible individuals must:

3. Check in with Darling Quarter staff on the day of the run

Entry into the Promotion is NOT confirmed by RSVP alone. Participants must physically attend and be checked in by authorised Darling Quarter staff on the day of the event to be eligible for prize draws.

It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's database and to be used in accordance with the purposes set out in these Terms and Conditions, of which they may opt out at any time.

LIMITS ON ENTRY

One entry per person per event.

PRIZES

4 x \$50 Darling Quarter digital gift cards will be awarded at random to eligible participants who have been checked in by Darling Quarter staff on the day of the event.

Winners will be notified via email and announced on Darling Quarter social media channels. Prizes will be distributed via email no later than 7 days after the event date (by Wednesday, 16 September 2026).

Darling Quarter gift cards are digital and will be emailed to winners. Gift cards are valid for 3 years from the date of purchase and can be redeemed at all Darling Quarter retailers. Any ancillary costs associated with redeeming the gift cards are not included. Gift cards are not transferable, not exchangeable, and cannot be redeemed for cash. Gift cards are subject to the standard terms and conditions of Darling Quarter.

GENERAL

Incomplete, indecipherable or illegible entries will be deemed invalid.
